

I HEART POCUS GIVEAWAY TERMS AND RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: This Campaign is open only to those who are 18 years of age or older as of the date of entry. The Campaign is void where prohibited by law.
